Instructions to the candidates:

- Candidate must be present in-person.
- The candidates should bring FC/ARC Acknowledgement print and valid proof of Merit List Status or Provisional allotment letter (**Photocopy and Original**).
- The eligible candidates seeking admission should be able to produce all necessary documents in original for the admission process along with FC verified photocopies of original documents.
- Candidate who had already taken admission in other institutes should produce required documents in original or attested photocopies of FC verified documents (from Principal of the college or head of the institutions where the documents are submitted) alongwith Bonafide certificate of the same.
- In case if the original documents, which are being submitted later, are found to be inappropriate or insufficient and admission is not granted/confirmed in the institute, the responsibility lies completely with the candidate himself/herself.
- The eligible candidates seeking admission will have to pay full prescribed fees immediately at the time of admission. The candidate is required to pay the fees through DD in favour of "**Principal, Government College of Pharmacy, Amravati**" payable at Amravati.
- Candidate has to cancel previous admission immediately to confirm allotted admission at Government College of Pharmacy, Amravati.
- All eligible candidates (Appeared in the merit list published on 23/06/2018 for B. Pharm., Pharm. D. and 24/07/2018 for M. Pharm. respectively) may attend this round.
- Attending the counselling round does not guarantee the offer of a seat.
