### **Guidelines for the Admission Process to be carried out by Govt., Govt. Aided, Govt. Aided University Managed Institutes and University Departments**

- i. All the candidates appeared in Final Merit List of Diploma Candidates
- ii. All the eligible Diploma Candidates from Maharashtra

### **The Eligible Candidate has to approach to the Principals/Director of the Respective Institutions for the Admission.**

### **General Notes:**

- ❖ The Vacancy Position and the detailed schedule will be available at the Respective Institutes.
- ❖ Any seat from that Institute (to which a Candidate may have been Admitted in Earlier Rounds) falling vacant due to change in Admission i.e. Admission to a different seat in the current round, shall be made available to the next Candidate in Merit.
- ❖ Candidates Admitted in the Govt. / Govt. Aided / Govt. Aided University managed Colleges/ University Departments in these rounds are not required to pay the fees if the Candidate has already secured Admission in any Govt. / Govt. Aided / Govt.
