- If the candidate who is admitted elsewhere for any of the courses and has submitted attested photocopies of the required documents at the time of his/her admission, such candidates **shall** be required to pay the full fees immediately at the time of admission and such candidates shall be permitted to submit the required original certificates within 04 working days after the date of payment of fees. Otherwise his/her admission will stand automatically cancelled and the fees shall be forfeited (i.e. non-refundable fees).
