- The candidate must attain the admission round **in person** as per above schedule.
- The vacancy position is subjected to change at any time and will be filled immediately during round notified as above.
- The fee structure mentioned below is a tentative fee structure. Exact amount of fees has to be deposited in cash at the time of admission. Candidate shall confirm the admission by paying the requisite amount of fee **(DD or Cash) of the course** to which admission is granted and by submitting all required documents **in original** at the time of admission only.
- If the candidate fails to substantiate the claim made at the time of submitting necessary original documents within the reporting time for CAP Round, the candidate forfeits the claim on the allotted seat.
- At the time of verification while submitting the application for institute level admission round, if candidate is unable to produce original certificates at the time of his/her admission on account of admission already secured to some other institute, he or she **shall produce a certificate from the Head of the institute** where he/she has already taken admission indicating that he/she has been admitted to a particular course in that institute on a particular date and hence original certificates have been retained in that institute. The candidate shall **also produce the attested copies of the certificates duly attested by the Head of the concerned institute.** (Refer Rule No. 5(iii), Page No. 30 and 31 of the Information Brochure.)
- If the candidate who is admitted elsewhere for any of the courses and has submitted attested photocopies of the required documents at the time of his/her admission, such candidates **shall be required to pay the full fees immediately** at the time of admission and such candidates shall be permitted to submit the required original certificates within 04 working days after the date of payment of fees. Otherwise his/her admission will stand automatically cancelled and the fees shall be forfeited (i.e. non-refundable fees).

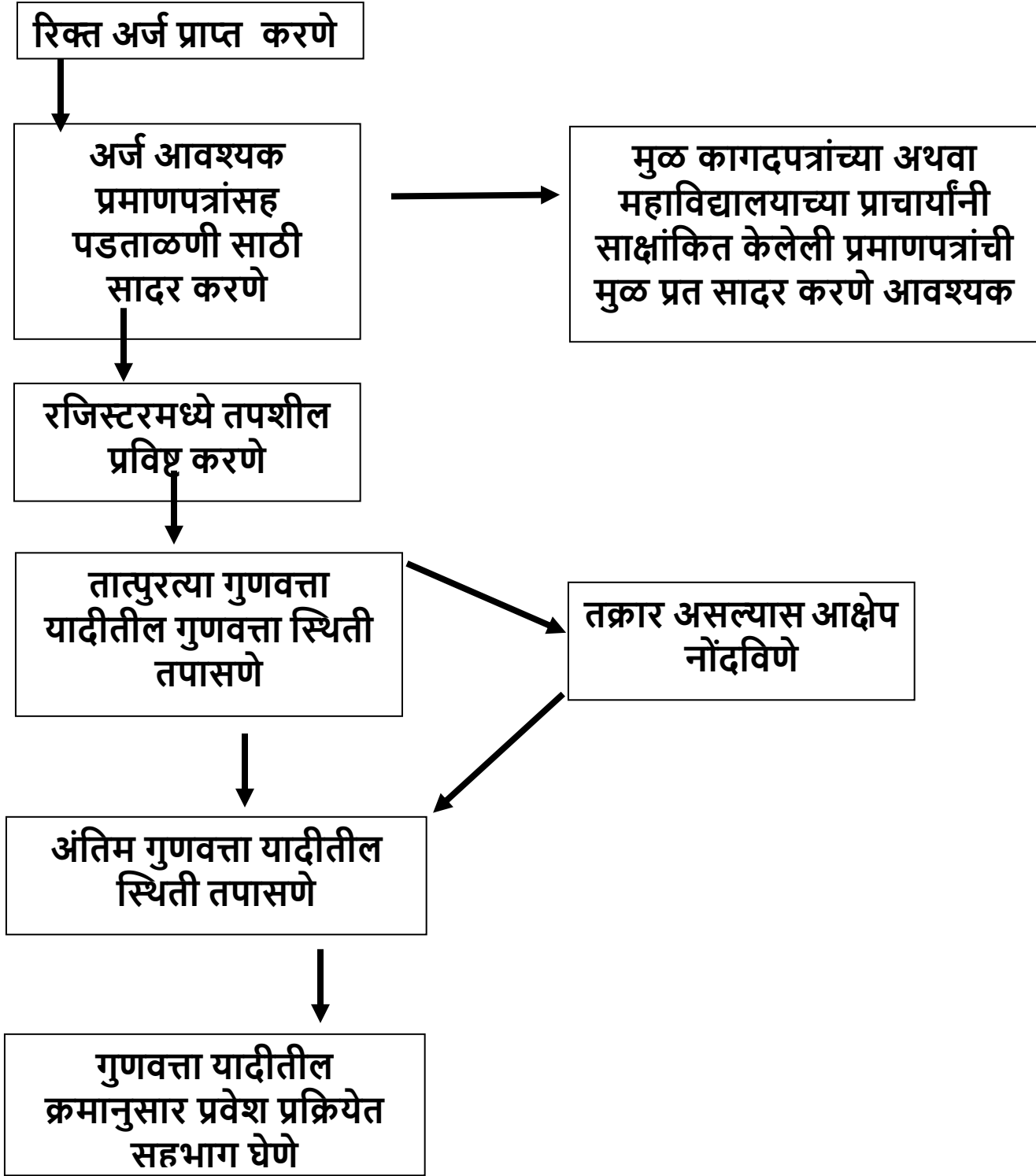

- Step 1-** Issue the Blank application form.
- Step 2-** Fill the form in legible and clear handwriting
- Step 3-** Attach following documents while submitting application form
- 1. Valid proof of Merit status (print of merit status in merit list) or allotment letter**
 - 2. Photocopy of FC acknowledgement of application verification or allotment letter**
- Step 4-** Verification of original Documents OR attested copies of documents from the principal of the institute for the candidates who have admitted to other institute.
- Step 5-** Submit the form at FC/ARC- hall. Enter the details in the register as proof of your submission.
- Step 5-** Check the merit list status in provisional merit list and report the grievance, if any, in time. Reporting the grievance after prescribed time shall not be entertained in any case.
- Step 6-** Strictly follow the time line as per schedule.
- Step 7-** Keep all the documents, in original, ready for verification. For already admitted candidates, they should carry attested copies of documents from the principal of the institute in which they have admitted alongwith Bonafide certificate duly signed by principal. Such candidates will have to pay Full Fees if allotted the seat for admission.
- The eligible candidates seeking admission will have to pay full prescribed fees immediately at the time of admission. The candidate is required to pay the fees through DD in favour of "Principal, Government College of Pharmacy, Amravati" payable at Amravati.**
